



## **Town Board Regular Meeting November 13, 2018**

---

The Town Board of the Town of Chester convened at the Town of Chester Municipal Center, 6307 State Route 9, Chestertown, New York, at 7:00 pm.

**Roll Call:** Supervisor Craig Leggett, Karen DuRose, Mike Packer, Larry Turcotte, Steve Durkish and Attorney for the Town, Mark Schachner.

Supervisor Leggett opened the Town Board Meeting at 7:03 pm with the Pledge of Allegiance.

### **Whitman Septic Public Hearing:**

Supervisor Leggett opened the Public Hearing with the Town Board acting as the Local Board of Health in the matter of **Paul and Eileen Whitman Septic System Variance #SV2018-02**, for property located at 625 Atateka Drive, Tax Map #: 102.19-1-15 at 7:04 pm.

Tom Hutchins from Hutchins Engineering represented Mr. and Mrs. Whitman. Mr. Hutchins explained that the current septic system is no longer functional and they are looking to install a new system. The only well affected is the owner's well which has more than 80' of casing and is grouted into bedrock and then is over 500' into the rock. Mr. Hutchins stated that Cedarwood Engineering, Engineer for the Town recommended adding an ultraviolet disinfection unit on the water supply to the house as an extra measure of protection and his client has no issues with doing that. Supervisor Leggett asked the audience if there were any questions. There were no questions. Mr. Turcotte asked if the basement was finished and if there would be a geo-liner. Mr. Hutchins replied that he was not sure if the basement was going to be living space however there would be a new foundation. Jill Broderick asked if this was going to be a convention septic system. Mr. Hutchins stated that it was going to be a 1,000 gallon tank with an absorption bed.

Supervisor Leggett **closed** the Public Hearing in the matter of Paul and Eileen Whitman Septic System Variance #SV2018-02 at 7:12 pm.

### **Tax Levy Limit Override Public Hearing:**

Supervisor Leggett stated that it was not needed at this time because the Town will be under the tax cap.

### **Property Maintenance/Blight Local Law Public Hearing:**

Supervisor Leggett opened the Public Hearing on the proposed **Property Maintenance/Blight Local Law** at 7:13 pm and asked the audience if there were any questions or comments.

Rand Fosdick started out with grammatical suggestions and said that the definition of the word "blight" should be included, asked for the Town to be more specific and then he asked the Board if the Town really needs this Law. Pat Powers asked how this would affect the Town property issues. Tom Thorsen stated that the Law will help the Town with the ability to follow up. Pat asked if this was going to change the existing Zoning Laws. The Attorney for the Town stated that if the Law was adopted it would be a standalone local law that could carry fines and be held up in Town Court or even the Warren County Supreme Court if necessary. Jill Broderick feels that a lot of the proposed local law is taken care of by the Board of Health and asked why this was not under the Zoning Laws. Supervisor Leggett replied that it is less cumbersome to pass a local law. Kathy Bilfield stated concerns about developers ripping apart property and leaving it for long periods of time. Mr. Turcotte would like to see an order for a potential emergency.

Supervisor Leggett **closed** the Public Hearing in the matter of the proposed Property Maintenance/Blight Local Law at 7:13 pm.

Supervisor Leggett closed Committee Reports at 7:39 pm.

**Privilege of the Floor:**

Supervisor Leggett opened Privilege of the Floor at 7:39 pm.

Mary Clark asked if there were going to be more meetings scheduled in Pottersville. Supervisor Leggett replied that would be taken care of at the Organizational Meeting in January. Mary asked about the Pottersville basketball court lights. Brett Hitchcock replied that they are wired and waiting for inspection so then the meter can be installed.

Kathy Bilfield stated that the noise on Schroon Lake from Word of Life (WOL) is too loud and the sound carries on the Lake. The rodeo, jubilee and soccer are way too loud and they are intending to expand. Elinor Muller lives across from WOL and has no problem with the noise. Ross Schoembs stated that for every person who does not have a problem with the noise he could bring you ten neighbors that do. Ross said that WOL is in violation for the Town Noise Ordinance and the Board should address this. Roger Peace, President of the WOL Bible Institute, spoke about the prior comments: WOL tries their hardest to be good community members; the Rodeo is free to the community and was moved from the afternoon to the evening at the request of the public and WOL has purchased new speakers to direct the sound to a specific space; the jubilee sold 2,800 tickets last year and ran 2 days from 11 am to 10 pm. Mr. Peace said that the College has been there since 1971. At the Town's request they installed a walkway for the students and the concert has no reflection on the building that WOL is looking to build. Ross Schoembs stated that the concert should not be held, that it is not a venue for a Christian rock concert and asked if the Town could survey people who are directly impacted by the concert event. Supervisor Leggett reminded the audience that the Board is there to listen during Privilege of the Floor and usually do not take action. Elinor Mueller stated that they have built a new cafeteria and they have not heard any new noise and that the noise from day to day life has not changed. Kathy Bilfield said they are good neighbors; however, people should not have to lose a whole weekend for a jubilee. Supervisor Leggett thanked everyone for their input.

David Gross, NWEMS Representative and Acting Chairman, reported in the operations report for Warren County, that there were 44 calls. Of those calls 29 were Chester, 9 were Horicon and 6 were mutual aid. EMS now has an ALS Intercept Agreement with Schroon Lake to recoup some the funds and are working on how to bill. EMS needs a board member; please send a letter of intent and resume. David spoke about removing an ambulance, the "Blue Bird", from the fleet.

Supervisor Leggett closed Privilege of the Floor at 8:10 pm.

**RESOLUTION NO. 197 OF 2018: APPROVE WHITMAN SEPTIC VARIANCE #SV2018-02**

**WHEREAS**, the Town Board acting as the Local Board of Health has received a completed application and has held a public hearing regarding the Septic Variance Application #SV2018-02 for property located at 625 Atateka Drive, NY, Tax Map #120.19-1-15, and

**WHEREAS**, according to Section 5.060 — Variances of the Town of Chester On-Site Wastewater Treatment Local Law the Local Board of Health may vary or adapt the strict application of any of the requirements of this Ordinance in the case whereby such strict application would result in unnecessary hardship that would deprive the owner of the reasonable use of the land involved, and

**WHEREAS**, no variance in the strict application of any provision of the Ordinance shall be granted by the Local Board of Health unless it shall find all 3 listed criteria applicable,

**BE IT RESOLVED**, the Town Board acting as the Local Board of Health finds the septic variance application meets the following criteria:

- a) That there are special circumstances or conditions, fully described in the findings of the Local Board of Health, applying to such land and that such circumstances or conditions are such that strict application of the provisions of this Ordinance would deprive the applicant of the reasonable use of such land.
- b) That the variance would not be materially detrimental to the purposes and objectives of this Ordinance, or to other adjoining properties, or otherwise conflict with the purpose or objectives of any plan or policy of the Town.
- c) That, for reasons fully set forth in the findings of the Local Board of Health, the granting of the variance is necessary for the reasonable use of the land and that the variance, as granted by the Local Board of Health, is the minimum variance which would alleviate the specific unnecessary hardship found by the Local Board of Health to affect the applicant.
